Election of the Office Bearers for the year 2014 - 2016

Dear Members,

Notice is being hereby issued for the Election of the Office Bearers of the Indian Society of Electrophysiology for the year 2014 - 2016 for the following posts :

1. President Elect	One	Term 1 year	(Year 2014-2015)
2. Vice-Presidents	Three	Term 2 years	
3. Hon. Secretary	One	Term 2 years	
4. Treasurer	One	Term 2 years	
5. Members	Eight	Term 2 years	

Rules and Regulations will be as per the Constitution

President Elect : The President Elect shall be elected annually from the among the members of the Society and should have a standing of at least 10 years in the Society and should have previously served for at least 1 term on the Executive Committee. He/She shall hold the office for one year. He/She will automatically become the President following year. No person shall be eligible to be elected as President Elect for more than one term. Once the member serves the Society as President for one term, he/she shall not be eligible for contesting for any posts of the Society in the future.

Vice-Presidents : The Vice-President shall be elected every two years from the among the members of the Society and should have a standing of at least 10 years in the Society and should have previously served for at least 1 term on the Executive Committee. They shall hold the office for two years and will be eligible for maximum of two terms, consecutive or otherwise.

Hon. General Secretary : The Hon. General Secretary shall be elected from among the members of the Society and should have a standing of at least of 8 years in the Society and have previously served for at least one term on the Executive Committee. The Hon. General Secretary shall hold the office for two years. No person shall be Secretary for more than three terms, consecutive or otherwise.

Joint Secretaries : There will be 2 Joint Secretaries. They shall be elected from among the members of the Society and should have a standing of at least 5 years in the Society and have previously served for at least one term on the Executive Committee. The Joint Secretaries shall hold the office for two years. No person shall be Joint Secretary for more than 3 terms, consecutive or otherwise.

Treasurer : The Treasurer shall be elected from among the members of the Society and should have a standing of at least of 8 years in the Society and have previously served for at least one term on the Executive Committee. The Treasurer shall hold the office for two years and will be eligible for maximum three terms, consecutive or otherwise.

Elected Members : There will be a total of 8 elected members. The elected members shall be elected from among the members of the Society and should have a standing of at least of 5 years in the Society. The Elected Members shall hold the office for two years and will be eligible for maximum two terms, consecutive or otherwise.

Those who wish to serve the Society as the Office Bearer are requested to send their nomination in the Assent Form enclosed for the post requesting for, duly proposed and seconded by valid member of the Society to the undersigned by 5th March 2014, 4.00 p.m.

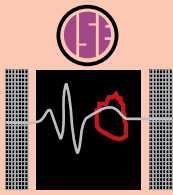
